Application Process

You (Artist) are applying to become a member of the Arrowhead Gallery (Gallery). The Gallery is part of the Southern Utah Art Guild (Guild) and does business under their non-profit status. All artists must be juried into the Gallery and meet the conditions stated in this Contract. Please read the contract carefully before proceeding.

Please provide the following:

- This completed Artist Application and Contract
- A \$25 non-refundable application fee
- 10 jpg images (max. 1200 megapixels on long side) that best represent your gallery-ready artwork (finished, including frame, etc.).
- A half-page artist biography focusing on your motivation to create art
- A photo of yourself
- In addition to these items, you are required to be a current member of the Guild.
- Check your requested Gallery space:
 - 4' @ \$35 per month _____
 - 6' @ \$50 per month _____

Bring your completed application/contract and fee to the Arrowhead Gallery. Then email the required images, biography and photo to **arrowheadgalleryart@gmail.com**.

Once the Gallery has all the required items, we will then send your images (anonymously) to be reviewed by an independent jury of selected Utah artists who are not members of The Guild.

The Gallery will notify you via email of the decision. If accepted into the Gallery, you may be placed on a waiting list until Gallery space for your medium becomes available.

Contract

The terms of this contract are as follows:

- All artwork must be original and solely created by the Artist.
- Copies or giclée's are not allowed to be displayed in the Gallery with the exception of Photography. See Gallery Policies and Procedures for details.
- All artwork must be suitable for viewing by the general public. No lewd or offensive material is allowed.
- All artwork must meet current Gallery display standards.
- All artwork must be for sale.
- Gallery receives a 25% commission on all sales made through the Gallery.
- New artists are required to make an initial six-month commitment to the Gallery and pay their first two months of Gallery space rent in advance.
- Artist is required to work at the Gallery on a volunteer basis for two four-hour shifts per month or serve as a member of the Southern Utah Art Guild Board of Directors.
- Artist is required to read and abide by the Gallery Policies and Procedures.
- Monthly Gallery space rent is due on the first day of each month.
- Artist will be paid for sales made in the current month by the 15th of the following month.
- If an Artist owes monthly rent to the Gallery that remains unpaid and delinquent for a period of more than ninety (90) days, Artist will forfeit all their work on display in the Gallery and that work shall thereupon become property of the Gallery without further notice or payment obligation to the Artist. Artist will also no longer be a member of the Gallery.

- Artist has inspected the Gallery and understands that the display space leased by the Gallery from the City of St. George (City) is an undivided portion of the Electric Theatre Complex (ETC) and is therefore not a secure space. Artist has been informed of, understands and accepts that City staff and invitees under the terms of the lease between the Gallery and the City have unlimited access to Gallery space at any time and without notice. Further, that the general public who are attending events at the ETC may have access to Galley space before, during and after Gallery business hours. Artist agrees that neither the City, the Guild, the Gallery or any of the respective directors, officers, employees, contractors, staff or volunteers shall be responsible for any loss or damage to any of Artist's personal property, including works of art in the Gallery. Artist confirms that by entering into this Contract, Artist agrees to display works of art at Artist's sole risk and will hold harmless the City, The Guild and the Gallery for any claims arising out of any loss or damage which may occur.
